

## SHOWERGUARD ENCLOSURE SWEEPSTAKES OFFICIAL RULES

1. **HOW TO ENTER:** NO PURCHASE NECESSARY TO ENTER OR WIN. In order to enter, you must go online at the [www.ShowerGuardGlass.com](http://www.ShowerGuardGlass.com) website from January 1, 2011, through 11:59:59 p.m. on April 30, 2011, click on the "ShowerGuard Rebate Coupon" icon, and completely fill out the entry form. Participants may also enter by sending their name, address and daytime telephone number on a 3" x 5" postcard to: Guardian Industries, Attn: ShowerGuard Entry Form 14600 Romine Rd. Carleton MI, 48117. Sponsor is not responsible for incorrect, lost, late, damaged, misdirected, postage due, incomplete, illegible, mutilated, corrupted or incompletely received entries, for any reason, including by reason of hardware, software, browser or network failure, malfunction, congestion or incompatibility at Sponsor's server or elsewhere or entries not received by Sponsor in time for the random drawing.

Limit one entry per person; any person submitting more than one entry (even if by different means) may be disqualified.
